

What is the Draxxin Rebate Program?

The program is a way for eligible customers to receive rebates on qualifying DRAXXIN and DRAXXIN KP purchases.

Eligible customers who make a qualifying DRAXXIN product purchase will receive one of the following rebates:

- 50mL = **\$15** rebate
- 100mL = \$25 rebate
- 250mL = \$50 rebate
- 500mL = \$100 rebate

Who is eligible for the rebate?

Select customers who make a qualifying purchase are eligible for the rebate.

Leaders' Edge[™] customers are not eligible for the rebate.

How long does the program run?

Rebate offer valid on purchases made Jan. 1, 2024 through Dec. 31, 2024.

Where can customers find more information?

Refer customers to the DRAXXIN Rebate Program producer display in your store. Customers also can access DraxxinRewards.com or use their mobile phones to scan the QR code found on the producer display.





How does the rebate work? It's easy!

- An eligible customer purchases a qualifying DRAXXIN product.
- 2. The customer:
 - Texts the word **Rebates** to **75834** to receive a link to the rebate website (or scans the QR code)
 - Snaps a photo of the receipt* and uploads it to the website
 - Selects the payment type PayPal®, Venmo® or paper check
- Depending on the selected payment type, the customer provides an email address (for PayPal), username (for Venmo), or mailing address (for paper check).
- 4. Once eligibility is confirmed, the customer will receive a rebate in their selected payment type. PayPal and Venmo rebates will typically be paid within 48–72 hours of eligibility confirmation, whereas rebates paid via check will typically take 5–6 weeks.

This rebate promotion is offered by Zoetis US LLC for Draxxin product purchases made between 01/01/2024 - 12/31/2024.

The rebate will be administered by ACB, Inc. through the Zoetis Rebate Center, available at DraxxinRewards.com.
