Adult Horses (900-1,100 lbs): Provide 1 scoop (42.5 g) **twice daily for 60 days.** Maintenance level, provide 1 scoop (42.5 g) **daily for 120 days** and may continue to feed ongoing to help support healthy immune/neurological system.
